Indicative Fee Rates for 2025

Please note:

- 1. These fees are estimates only for students enrolling in (or currently enrolled in) government funded courses in 2025.
- 2. The indicative fees for a course may differ between training providers due to the units they have included in the course outline. The differences generally result from adapting courses to meet local industry needs.
- 3. Nominal hours are not hours of training or instruction. They are used to determine course fees and subsidy levels to reflect the cost to deliver quality training.
- 4. Concession and annual course fee caps may also apply to some courses. Fee caps apply to some tuition fees only. Note: Proof of eligibility for concession must be demonstrated prior to the commencement of the unit. If the concession is valid for the full enrolment period, then all eligible units commenced within that period attract the concession rate. If the concession is valid for part of the enrolment period, then only eligible units commenced prior to the expiry of the concession rate.
- 5. Fees have been quoted on the basis of 2025 fee rates only. These are expected to change in 2026.
- 6. Other charges may apply.

The Student tuition fees are indicative only and are subject to change given individual circumstances at enrolment. Additional fees may apply such as student service and resource fees.

The following students are entitled to the **concession** rate on course fees:

- a) Persons and dependants of persons holding:
 - i) A Pensioner Concession Card;
 - ii) A Repatriation Health Benefits Card issued by the Department of Veterans' Affairs; or
 - iii) A Health Care Card.
- b) Persons and dependants of persons in receipt of services from the following Commonwealth support of employment services programs:
 - i) Workforce Australia; or
 - iii) ParentsNext.
- c) Persons and dependants in receipt of AUSTUDY or ABSTUDY.
- d) Persons and dependants of persons in receipt of the Youth Allowance.
- e) Persons and dependants of persons who are inmates of a custodial institution.
- f) Secondary school-aged persons, not enrolled at school

Course fee caps

The maximum course fee for non-concession students undertaking a targeted fee relief course in 2025 is \$1,200. For concession and youth students (aged 17-24 years) the maximum course fee for undertaking a targeted fee relief course in 2025 is \$400.

For secondary school-aged persons not enrolled at school or secondary school-aged persons in their final year of school who will not, after the completion of that year be enrolled at secondary school and not undertaking a targeted fee relief course, the maximum course fee chargeable in 2025 is \$420. The maximum is the total fee for all courses the student is enrolled in.

Recognition of Prior Learning - Please note Recognition of Prior Learning fees do not attract concessions or course fee caps.
